The undersigned owner seeks approval of the Architectural Standards Committee (ASC) as follows:

These are Benjamin Moore (BM) colors and paint numbers as found in the Georgetown East HOA Board Approved Paint Book. Your house may only utilize two exterior house colors: a body color and a trim color. Only the front door may utilize a third accent door color.

Body/Garage Door/Chimney Stack Color Name:	BM #
Trim/Brick/Column (capital, shaft & base) Color Name:	BM #
Gutter/Downspout Color: <small>Gutters must be original white material or painted the exterior Trim Color. Downspouts must be original white material, painted the selected Trim Color or selected Exterior Body Color.</small>	BM #
Chimney Cap Color Name:	BM #
Front Door Color Name: <small>Choose a Door Color from a body, a trim, or an accent color.</small>	BM #

- The undersigned property owner hereby acknowledges and agrees that the paint colors are from the Georgetown East HOA Board Approved Paint Book. If the homeowner (or his/her contractor) elects to use another brand of paint, that paint **must match exactly** the Benjamin Moore color selection(s) chosen on this form. If another brand of paint is used and does not match the colors approved by the Architectural Standards Committee (ASC), the home must be repainted within thirty (30) days at the homeowner's expense. The ASC strongly recommends that your contractor be licensed and bonded to perform work in Pinellas County for your protection.
- Once your project is initialed and approved to begin, you have 30 days to complete the paint project. If there is a delay in completing the job within 30 days, it is incumbent on you to notify the ASC.
